



PUBLIC TLS CERTS OVER TIME







CAA will soon be enforced for S/MIME certificates

PKILINT

DigiCert releases significant update for its open source linting framework, pkilint, to support linting certificates against the Ballot SC-62 profiles

- Bundled with 6 command line programs, each wrapping a different linter
 - CABF S/MIME end-entity certificate
 - CABF TLS certificate
 - PKIX certificate
 - PKIX and CABF CRL
 - PKIX OCSP
 - PKIX issuer and subject certificates relationship
- Easy-to-install Python package available on PyPi: https://pypi.org/project/pkilint/

New S/MIME Baseline Requirements

- Effective as of September 1, 2023
- Affects all certs that:
 - Are Public trust
 - Have email Protection eKU
 - Include an email address
- First industry-wide rules for email certs
 - Verification of mailbox control as well as Organization and Individual identity
 - Cert profiles for both ICAs and lead certs
 - CA operations and compliance
- S/MIME Certificate Linter <u>project</u> open-sourced by Digicert




Chrome's phased approach

Support for automation



- Term limit for roots
- Establish minimum expectations for linting
- Phase out "multi-purpose" roots
- Phase out clientAuth use cases
- Strengthen domain validation

- US Food and Drug Administration's (FDA) software bill of materials (SBOM) mandate officially enforced from October 1st, 2023
- FDA is mandating that all medical devices running software must create and maintain an SBOM




C2PA


Coalition for Content Provenance and Authenticity – addresses misleading information

- Open standard for identifying and authenticating digital files
- Created by industry leaders Adobe, Microsoft, Sony, DigiCert and others
- Uses PKI to validate digital files


An Overview of the C2PA Life Cycle






